

FINANCIAL ASSISTANCE TO VAs/ NGOs/SHGs

Applications are invited from interested Registered Voluntary Agencies (VAs)/ Non Governmental Organisations (NGOs) for consideration for financial assistance from the **Chief Minister's Youth Development Scheme 2016 - 2017.**

Assistance under this scheme for 2016 - 17 shall include only the following activities

- (i) Short term seminar / workshops for the youth and youth related issues.
- (ii) Educational / Learning Exposure trips for the youths outside the State.
- (iii) Sports activities for the youths.
- (iv) Activities towards Youth Development.

The maximum budget estimate of the proposal(s) should not exceed ₹.50,000/- (Rupees fifty thousand) only.

The proposals submitted by the VAs/NGOs etc shall be scrutinized by the District Level Empowered Committee and the decision of the District Level Empowered Committee will be final.
